

RULES | Early Booking competition winter 2025-26

ARTICLE 1 - ORGANISER AND DURATION OF THE COMPETITION

2 Alpes Réservation - 2 Alpes Tourisme, located in Les 2 Alpes, is organising an Early Booking competition for the 2025-26 winter season (i.e. from 29 November to 5 May 2026), the winner€ of which will be chosen by drawing lots in accordance with the conditions defined below. The competition will run from 20 August to 30 August inclusive.

ARTICLE 2 - CONDITIONS FOR TAKING PART IN THE COMPETITION

- 2.1. Competition with obligation to purchase a stay of at least 1 week (7 nights) with a minimum value of 1000€ on the reservation.les2alpes.com website between 30/11/2025 and 05/05/2026.
- 2.2. Participation in the competition implies irrevocable and unreserved acceptance of the terms and conditions of these rules.
- 2.3. The competition is limited to one entry per person. Participation in the competition is strictly personal and nominative. Only one prize will be awarded per reservation file.
- 2.4. Failure to comply with the conditions of participation set out in these Rules will invalidate participation.
- 2.5. Entry to the competition is automatic as soon as a stay is booked in accordance with the above-mentioned criteria.

ARTICLE 3 - PRINCIPLE OF THE COMPETITION / CONDITIONS OF ENTRY

Each participant must meet the conditions of the competition in order to have a chance of winning the prize.

ARTICLE 4 - Designation of the winners

The Organiser will designate the winners by drawing lots from among all the people who have made a reservation of at least one week for the winter season between the dates indicated above. A draw will be held on 2 September 2025.

ARTICLE 5 - PRIZES

1 adult 6-day skipass to be won for booking accommodation on 2 Alpes Réservation.





ARTICLE 6 - AWARD OF PRIZES AND HOW TO USE THE PRIZES

The Organiser of the competition will contact the winner by e-mail and inform him/her of the procedures to follow to access his/her prize. No mail will be sent to participants who did not win, only the winner will be contacted. The winner must reply within two weeks of this e-mail being sent and provide their full details. If no reply is received from the winner within two weeks of the e-mail being sent, the prize will be forfeited and the winner will not be entitled to any indemnity, prize money or compensation whatsoever. In this case, the prize will be awarded to a substitute designated in the draw for the session concerned. The winner must comply with these rules. If it turns out that he/she does not meet the criteria of these rules, the prize will not be awarded to him/her and will be acquired by the Organiser. To this end, participants authorise all checks concerning their identity, age, their contact details or the fairness and sincerity of their participation. Any false declaration, false indication of identity or postal address will result in the immediate elimination of the participant and the acquisition of the prize by the Organiser.

The prize will be available for collection at the Tourist Office, place des 2 Alpes, during the winner's stay.

ARTICLE 7 - LIABILITY

The Organiser may not be held liable if it is impossible to contact each winner, nor in the event of loss, theft or damage to the prize during transportation. Nor can the Organiser be held liable for any errors in the name, address and/or contact details provided by the people who took part in the competition. Furthermore, the Organiser of the competition declines all responsibility for any incidents that may occur during the enjoyment of the prize awarded and/or due to its use and/or its consequences, in particular the enjoyment of a prize by a minor, who remains under the full and total responsibility of a person with parental authority. The Organiser reserves the right, if circumstances so require, to shorten, extend, modify, interrupt, postpone or cancel the competition, without incurring any liability. However, any modification will be the subject of an amendment which will be posted on the site and sent free of charge to any person who has requested the rules in writing. The Organiser declines all responsibility in the event of malfunction preventing access and/or the proper running of the competition, in particular due to external malicious acts. The use of robots or any other similar means to participate in the competition mechanically or otherwise is prohibited, and any violation of this rule will result in the definitive elimination of its creator and/or user. The Organiser may cancel all or part of the competition if it appears that fraud has occurred in any form whatsoever, in particular computer fraud in connection with participation in the competition or the determination of the winners. In such a case, it reserves the right not to award the prizes to the fraudsters and/or to prosecute the perpetrators of such fraud before the competent courts.
